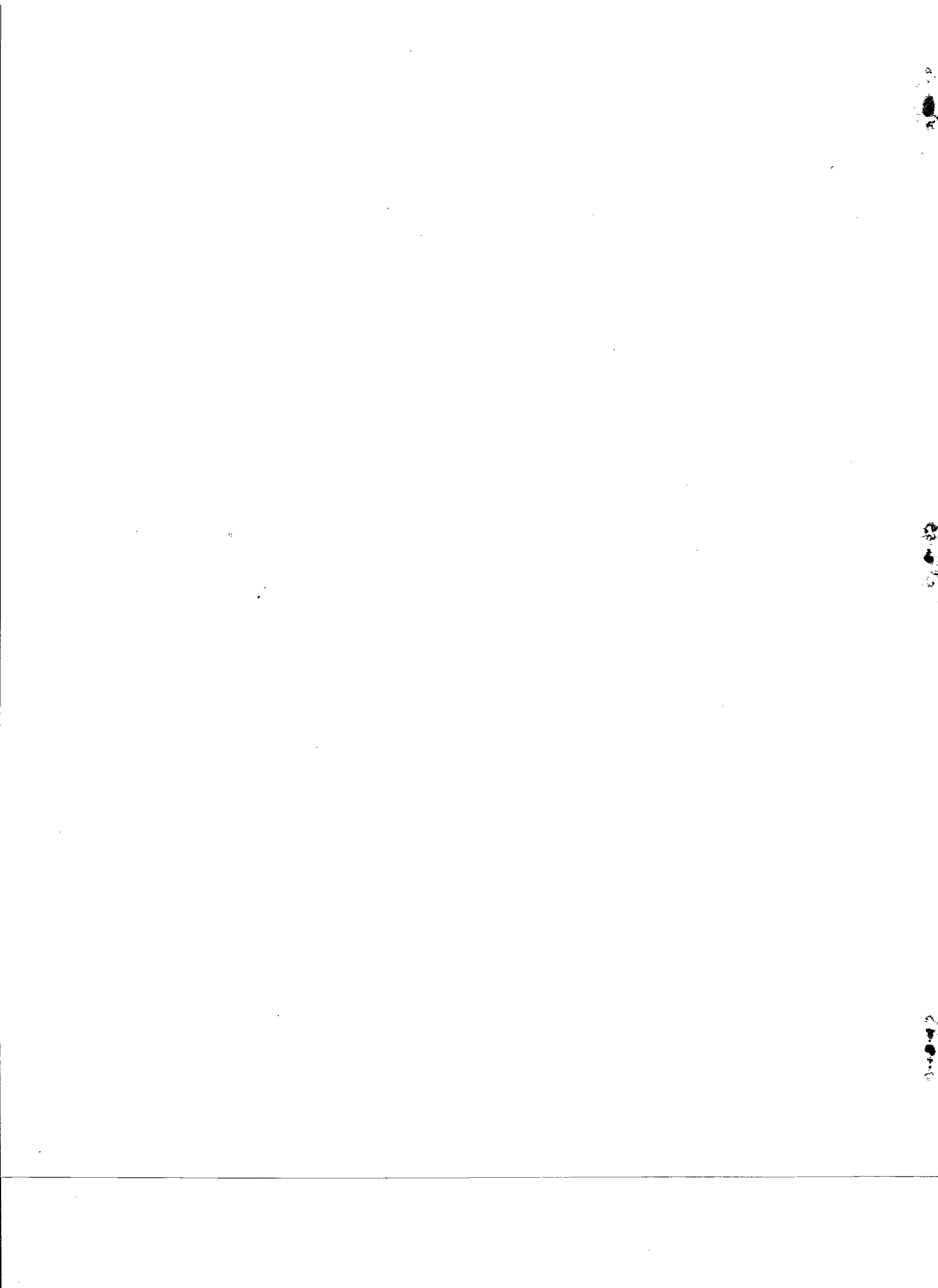

INTRODUCTION

The Directorate of Economics and Statistics has been regularly publishing annually the estimates of State Domestic Product. The estimates are regarded as the best Statistical device to measure the growth of the economy and also throw some light on the structural changes that are taking place in the State. But such estimates could not reflect the economic conditions of the districts and the economy of the districts cannot be studied through the estimates of the State as a whole. The necessity to have estimates of District Income at this level is very much felt by the Administrators and Planners. The Directorate of Economics & Statistics took up this challenge and started the estimation of District Domestic Product from the year 1993-94 onwards. With the introduction of the New Series known as National Account Statistics 1993, the estimation of State Domestic Product has been taken up by following the methodology provided by the Central Statistical Organisation, Government of India for the States. Accordingly, the old base year of 1980-81 has been shifted and revised with a new base year of 1993-94.

As such the estimation of District Domestic Product with the base year of 1993-94 has been started by following the methodology and appropriately adopted for different sectors of economy. In order to estimate the District Domestic Product, the quantity of commodities and services produced during a given period of time within the geographical boundaries of the Districts are measured in monetary terms. The estimates of District Domestic Product at Gross/Net District Domestic Product along with per capita income, provide useful indicator for assessing the growth as well as the standard of living of the people during the period which is generally referred to as a year. The estimates of Gross Domestic Product of the Districts may be used for analytical studies more than those estimates of Net District Domestic Product. This is felt in view of the fact that the estimates of Gross Domestic Product are more widely used in order to study the progress and development in the economy.

By concepts, the District Domestic Product are the aggregates of Gross/Net product at factor costs originating within the geographical boundaries of the districts over a certain period of time. The estimates however include all factors income irrespective of the fact whether these factors are owned by persons living inside or outside the districts. The non-economic activities do not come under the purview of the District Domestic Product.

METHOD OF ESTIMATION :

The estimates of District Domestic Product can be computed by adopting the following approaches such as production, income and expenditure approaches.

Under the method of production approach, the gross output of all commodities industries etc. is evaluated at factor cost less the purchasers' value of inputs, in order to estimate the Gross District Domestic Product.

Income approach is followed for estimation of income of those sectors, where information are available only on factor income like service sectors etc.

Expenditure approach on the other hand consists of aggregation of consumers expenditure, government expenditure on goods and services etc.

As regards estimates for Supra Regional Sectors which are directly supplied by the Central Statistical Organisation, Government of India the same are again re-allocated according to the norms applied as stated in the methodology adopted for the estimation of District Domestic Product. The estimates in respect of FISIM (Financial Intermediation Services Indirectly Measured) and arrived at for each sector of the economy at the State level, are again re-allocated to different sectors of each districts on the basis of the Gross Value of Output.

Estimation of Net District Domestic product has been arrived at after deducting Consumption of Fixed Capital (CPC) from the Gross Value Added (GVA).

SOME OF THE OBSERVATIONS

It is observed from the table 1.1 that the East Khasi Hills District was the District with the highest contribution to the State Domestic Product. The East Khasi Hills District contributed between 38.04% to 38.71 % during 1993-94 to 1999-2000 in the Gross Domestic Product at current prices. According to the estimates of Gross District Domestic Product . The South Garo Hills District on the other hand has the lowest contribution to the State Gross Domestic Product at current prices with percentages ranging between 4.89% to 5.69% during 1993-94 – 1999-2000.

The highest annual variation/ increase attained by the Districts during the period 1993-94 to 1999-2000 was the highest in respect of Jaintia Hills with 28.56% in 1998-99 and the lowest was 5.00% by South Garo Hills in 1997-98.

According to the estimates of Gross District Domestic t Product at constant(1993-94)prices, the East Khasi Hills was the main contributor to the economy with percentages ranging from 37.02% to 38.71%, and South Garo Hills accounted the lowest contribution to the economy with percentages ranging between 4.89% and 5.87% during 1993-94 to 1999-2000. according to Table 2.1.

The real Annual growth attained by the Districts was the highest with 20.72% by Jaintia Hills in 1998-99 and the negative growth of (-) 1.97 % by South Garo Hills in 1997-98 as shown in Table 2.2.

The same observations are noticed in the estimates of Net District Domestic Product at current prices and also at constant (1993-94) prices during 1993-94 to 1999-2000 as opined in Table 1.1, 1.2, 2.1 and 2.2.

The estimates of per capita Income of Gross District Domestic Product at current prices have shown East Khasi Hills to have recorded the highest per capita income ranging from Rs.10,316 to Rs. 19,522. However, the West Khasi Hills District with per capita income between Rs 5,605 and Rs 10,188 accounted the lowest per capita income among the districts during 1993-94 to 1999-2000 according to Table 5.1.

As regards per capita income of Gross District Domestic Product at constant (1993-94) prices, the East Khasi Hills accounted the highest per capita income, The per capita income of the East Khasi Hills ranged between Rs 10316 to Rs 13013, while in 1998-99 Jaintia Hills recorded the highest per capita income of Rs 13,360. West Khasi Hills has the lowest per capita income ranging between Rs 5,605 to Rs 7,097.

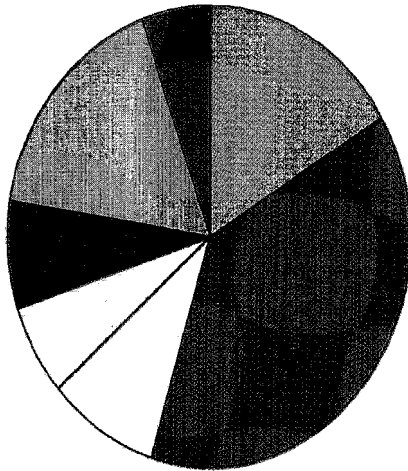


Percentage Contribution of Gross District Domestic Product to the State Total at Constant (1993-94) Prices

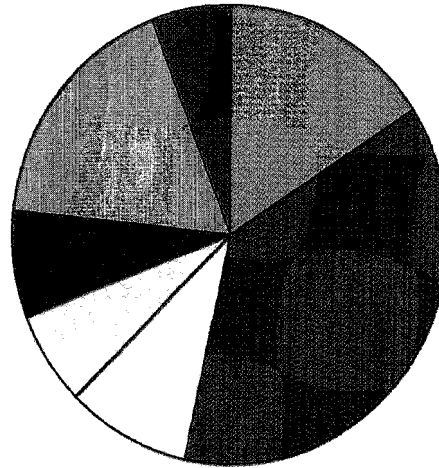

METHODOLOGY ADOPTED IN THE ESTIMATION OF DISTRICT DOMESTIC PRODUCT OF MEGHALAYA.

Output from Agriculture and Allied Activities :

The activities includes in this sector are (i) growing of field crops, fruits, nuts, seeds, and vegetables (ii) plantation, etc. (iii) foreyard and backyard cultivation (iv) breeding and rearing of animals and poultry including veterinary services (v) production of milk (vi) slaughtering, preparation and dressing of meat (vii) production of eggs, raw hide and skin, honey and silkworm and cocoon.

1. (i) Agriculture (proper) :

The estimates of Gross Value of Output from agriculture (proper) have been obtained by using the production approach. The figures in respect of area and outturn of principal crops etc. for each district as furnished by the State Forecast Committee and Land Utilisation Statistics are used. Information on District-wise outturn of other minor crops are furnished by the State Directors of Agriculture and Horticulture. According to the new Series Methodology, the System of National Account (1993 SNA), the Value of output for crops grown in the foreyard / backyard (kitchen garden) has been included in the estimates. Accordingly 0.22% of total rural area operated in the District is taken and evaluated with per hectare value of fruits and vegetables for estimation of value added. The process of evaluation is based on the report of operational land and Livestock holding survey 1991-92 (48th round of NSSO). Estimates of other by products such as, paddy, wheat, maize, gram, tur, sugarcane, cotton and jute sticks are worked out on the rate of per hectare area available for each district on the bases of cost cultivation studies.

Estimates at Current Prices :

The outturn of crops etc for each Districts is evaluated at primary whole sale prices (State weighted Average Prices) available during the Peak Marketing Periods during the current year.

Estimates at Constant Prices :

Estimates are arrived at by using the prices of the base year (1993-94) and the value of Outturn of Crops during the current year is used.

1. (ii). Livestock

The estimates of Gross Value of Output on Livestock and Livestock products are obtained by the production approach. The District-wise data on livestock are based on Quinquennial Censuses conducted by the State Directorate of Animal Husbandry and Veterinary and Census figures are then projected to other subsequent years. As regards other output of livestock and livestock products, the figures are directly available District-wise through the Annual Report on sample survey for estimation or production of milk, egg and meat. Evaluation on increment of livestock, etc. for the districts is done on the basis of projected census figures from one year to another for each district.

Estimates at current prices

The State weighted average prices available in selected markets during the current year are used to estimate the Gross Value of Output.

Estimates at constant prices

For estimation at constant price the prices of the base year (1993-94) are used against the outturn of livestock and livestock product during the current years.

1 (iii). Sericulture

Evaluation of sericulture products is based on the district data directly supplied by the State Directorate of Sericulture and Weaving. The information include the Output and prices of Sericulture products. The estimates at Current Prices for each district are arrived at by using the Current Prices of state weighted average prices while evaluation of Sericulture products and estimates at constant prices are arrived at by using the 1993-94 prices which is the base year for new series.

1 (iv). Honey

The output and average prices of honey are directly supplied by the Meghalaya Khadi and Village Industries Board for each year and for all the districts. The estimates at current prices are evaluated by using the current year prices while estimates at constant prices, the base year (1993-94) prices are used for other years.

The Gross Value added of each Districts at current and constant prices from Agriculture and allied activities are arrived at after deductions of the value of input items. The estimates of inputs such as seeds, are worked out on the basis of rate per hectare. The estimates on organic manure and Feed for Livestock are worked out on the basis of the rate per bovine/animal or bird on norms supplied by the CSO.

As regards market charges, the norms supplied by the Central Statistical Organisation (CSO) are used. Other input items, such as Electricity, Chemical, Fertilizer, Bonemeal, Insecticides & Pesticides, Diesel Oils etc., are allocated to Districts by the ratio of the Value of Output of Agriculture but in the case of Current repairs and maintenance, the same had been allocated by the ratio of the total Output of Agriculture and Livestock.

2. Forestry And Logging

The activities covered in this sector include felling and rough cutting of trees, healing or rough shaping of poles, block etc. and charcoal burning carried out in the forest and gathering of uncultivated materials etc.

Estimates at current and constant prices.

The estimates of Gross Value Added at current prices are arrived at for the state during the current year and the same have been allocated according to the area under forests in each district. In the same manner, estimates, of Gross Value Added at constant prices, the base year prices (1993-94) are used accordingly for other years.

The total Gross Value Added of Industrial wood and other minor Forest products of the State have been allocated both at current and constant prices to each districts on the basis of the area under Forest (Reserved and un-classed Forests) available from the Land Utilization Statistics of the Districts.

3. Fishing

The activities included in this sector are Commercial fishing in the inland water only. Fish catching, tackling and gathering of fish from river tanks and artificial ponds and fish curing like salting and sun-drying of fish.

(i) Inland Fishing :- The estimates for inland fishing are done on the basis of data / outturn supplied by the Fishery Officers of the Districts.

(ii) Subsistence Fish :- The estimates for subsistence Fish are also done on the basis of data/outturn supplied by the Districts Fishery Officers.

The estimates of Gross Value Output from this sector have been obtained by following the production approach both at current and constant prices. The Gross Value Output of each district is estimated on the basis of production /outturn of fish during the year.

Estimates at Current/ Constant Prices /

The State weighted average wholesale prices are used in order to evaluate the production /outturn for each year. As regards estimates at Constant prices, the State weighted average prices of the base year (1993-94) are used for evaluating the output for each year.

The estimates of Gross Value Added have been arrived at by deducting the cost of repairs and maintenance and operational cost both at current and constant prices (inland fish 10% and subsistence fish 1%) according to the norms supplied by the CSO.

4. Mining and Quarrying

The economic activities covered in this sector comprised extraction of minerals which occur in nature as solids, liquids, gases underground and surface mines. Quarries etc, with supplementary operations for dressing, beneficiating ores and other crude minerals such as crushing, screening, washing, cleaning, grading, milling, floating, melting etc. All these activities are covered to the extent as carried on at the mine site.

Estimated at Current /Constant Prices

The value added from this Industry is estimated by production approach. The quantities of limestone along with prices are furnished by the State Department of Mineral Resources district-wise. The pit head value of coal is furnished by the respective District Statistical Officer collected from source of production. As regards estimates of minor minerals, the State estimates of Gross Value Added have been allocated to the Districts on the basis of area under Forest available from the Land Utilization Statistics of the Districts.

The Gross Value Added of mining and quarrying has been worked out according to the norms and ratio provided by Indian Bureau of Mines / Central Statistical Organisation from time to time.

The estimates at Constant prices have been obtained by using the base year 1993-94 prices on Current year production. For minor minerals the same method as done in current prices is followed.

5. Manufacturing

Manufacturing activities is divided into two broad sectors, 'Registered' and 'Un-Registered'. The Registered sector includes all factories covered under section 2m (i) and 2m (ii) of the Indian Factories Act 1948. Manufacturing units other than those covered under the Factories Act, including household industries form the "Un-organised" or 'Un-registered' Manufacturing sector

5.1 Manufacturing (Registered)

The output and input data for Manufacturing (Registered) are directly available from the annual returns furnished by the National Sample Survey Organisation, FOD, Shillong and district estimates were worked out according to the location of the units. Production approach is adopted to arrive at the estimates of Gross Value Added at current prices. The estimates of Gross Value Added at constant prices are obtained by deflating the current prices estimates with the help of wholesale price index (W.P.I).

5.2 Un-Registered Manufacturing

Estimates at Current Price

The estimates of Gross Value Added of the State at current prices have been allocated to the Districts on the basis of the working force engaged in manufacturing in each district as available in the 4th Economic Census Report 1998. In the same manner, the estimates of State Gross Value Added at constant (1993-94) prices are used accordingly for other years.

6. Construction

Construction activities covers all new constructions, repairs and maintenance such as buildings, highways, streets, bridges, culverts, sub-ways, parking areas, dams, drainage, wells, irrigation, plantation, afforestation, etc.

Estimates at Current and Constant (1993-94) Prices.

(A) Public Sector :- The estimates for each district has been obtained by allocating the State estimates on the ratio of expenditure on construction works for each districts available from the budget estimates of State PWD . In the same manner, estimates of Gross Value Added at constant prices, base year price (1993-94) are used for other years.

(B) Rural & Urban Residential Buildings :- The State estimates Gross Value Added both Rural and Urban buildings including non-Residential and other construction works have been allocated to each districts on the basis of no. of District-wise Rural and Urban residential buildings (Census 2001) both at current and constant with the base year (1993-94) prices.

(C) Residual :- The estimates of Gross Value Added of Residual of each district both at current and constant prices have been obtained through allocation from the State total by the number of working force available in the Report of 4th Economic Census 1998.

7. Electricity, Gas & Water Supply

The estimates of Districts Domestic Product on Electricity, gas, and water supply at current prices have been arrived at by allocating from the State total on the ratio of the number of Employees in each district. In the same manner the State Gross Value Added at constant (1993-94) prices is arrived at for the other years.

8. Transport, Storage and Communication

The economic activities covered in this sector are transportation by Government and Non-Government and Transport by other means viz ,Road transport (mechanized and non-mechanized), Air transport and services incidental to transport, storage and communication, services rendered by post and Telegraph Department and overseas Communication services.

8.1 Transport by other Means

(a) Mechanized Transport (Public Sector) :- Income approach is used in order to estimate the Gross Value Added of public transport by analysing the annual statement of Account/Balance Sheets of M.T.C. How-ever, for the estimate of District Domestic Product, the same have been allocated to each district as per the number of working force both at Current and Constant (1993-94) prices

(b) Mechanized Transport (Private):- The estimates of Gross Value Added of the state both at Current and Constant(1993-94) prices have been allocated to the districts based on the total number of vehicles (i.e., NIC,701,702,703) supplied by the State Commissioner of Transport for all Districts.

(C) Non- Mechanized Transport :- The State Gross Value Added both at current and constant (1993-94) prices have been allocated to the districts based on the number of workers available from the report on the 4th Economic Census 1998 (Meghalaya).

8.2 Storage

The State estimates of Gross Value Added on current price have been allocated to each districts on the basis of number of working force available from the 4th Economic Census Report 1998. Estimates at constant (1993-94) have been arrived for each district in the same manner.

8.3 Communication

The Gross Value Added as supplied by C.S.O for the State have been allocated on the basis of no. of post offices and telephone connection of each District both at current and constant prices.

9. Trade, Hotel & Restaurant

The activities covered in this sector are (I) wholesale and retail trades (ii) purchased and sale agents and brokers (iii) Auctioneering (iv) Services rendered by hotels, restaurants, café and others and drinking and lodging places.

The estimates of this sector, both at current and constant (1993-94) prices for each districts have been arrived at by allocating the State Gross Value Added by the number of working force obtained from the report of the Fourth Economic Census 1998.

10. Banking and Insurance

The State estimates of Gross Value Added are initially allocated between Banking and Insurance on the average ratios of liabilities and assets of 95 % for Banking and 5% for Insurance (as available in the Statistical Abstract of government of India). Separate Gross Value Added is then allocated to district for Banking on the bases of the number of Banks and for Insurance allocation is made to districts according to the number of workers.

11. Real Estate, Ownership of dwelling, business services and Legal Services

The economic activities covered in this sector are (I) real estate services (activities of all types of dealers such as operator, developers and agents connected with real estate (iii) ownership of dwelling (occupied residential houses) (iii) business services.

The estimates of Districts Domestic Product on Real Estate, Ownership of dwelling, Business Services and Legal Services, etc both at current and constant prices have been obtained by allocating separately the Gross Value Added of Rural and Urban by the number of Rural and Urban Residential buildings of each districts respectively.

12. Public Administration

Public Administration covers services rendered by the Administrative Departments of Central Government, State Government and Local Bodies (Municipalities, Town Committees, Autonomous District Councils). The estimates of Gross Value Added from this sector have been prepared separately for the following categories :-

- (i). Central Government Administration.
- (ii). State Government Administration.
- (iii). Quasi Government Administration.
- (iv). Local Bodies Administration.

The estimates of State Gross Value Added of this sector both at current and constant (1993-94) have been allocated to the districts as per the number of Employees (State, Central, Local Bodies and Quasi Government) of each district.

13. Other Services

The Economic activities covered under this sector are (I) Educational Services (ii) Research and Scientific Services (iii) Medical and Health Services (iv) Sanitary Services (v) Recreational Services including T.V and Radio, (vi) International and other extraterritorial bodies (vii) Rest of Services (community Services NIC 964, Personal Services NIC 96 and services NIC 99 and (viii) Tailoring Services NIC 964. The estimates of Gross Value Added have been prepared separately for each services.

13. (i) Educational Services

The State Gross Value Added under this sector both at current and constant (1993-94) prices has been allocated to the districts based on the number of teaching and non-teaching staff of each districts.

(ii) Medical & Health Services

The estimates of State Gross Value Added of Medical & Health Services, that is Public, Private (organised) and private un-organised have been allocated to each districts on the basis of number of Medical and Para-Medical personnel posted in each district both for current and constant (1993-94) prices.

(iii) Rest of Services including Sanitary (Public & Private) Research & Scientific, tailoring Services, etc

The estimates of State Gross Value Added both at current and constant (1993-94) prices under these sub- sectors have been allocated to the districts, on the basis of number of working force available from the Report of the 4th Economic Census of 1998, Meghalaya.
