P R E F A C E

The brochure on the estimates of Gross Domestic Product (GDP) of Meghalaya is the second publication on the New Series (1993-94) and sixth in the series. The sources and methods in working out the estimates of Gross/Net Domestic Product both at current and constant prices are the continuing process of the first publication (New Series 1993-94). In the present publication, revisions have been made in respect of Agriculture, Manufacturing (Un-registered), Transport by other means and Trade, Hotels & Restaurants. It contains the sectoral estimates of GDP/NDP, annual sectoral increase/growth over the previous years and sectoral contribution both at current and constant (1993-94) prices and also includes the industry-wise estimates of GDP/NDP, percentage contribution, percentage variance/growth over the previous years and Per capita income both at current and constant (1993-94) prices for the years 1993-94 to 2001-2002 (Adv). This publication is prepared by the State Income Division/Section of the Directorate of Economics & Statistics.

The co-operation extended by the different departments of the Government, local authorities, Departmental commercial and Non-departmental undertakings is gratefully acknowledged. Guidance provided by the National Accounts Division, Central Statistical Organisation, New Delhi through training, workshop and discussions is of immense value which is highly solicited.

Lastly, I hope that this publication would serve the needs of administrators and also useful to the research scholars and other social scientists.

INTRODUCTION

The Directorate of Economics & Statistics Meghalaya Shillong has been preparing regularly the estimates of State Domestic Product at current prices, as well as at constant prices. The estimates at current prices are worked out by evaluating all the goods and services at factor cost / producers prices prevailing during the year. On the otherhand, the estimates at constant prices are arrived at by using the base year prices, thereby eliminating the effect of price changes and invariably reflect a better view on the real growth or development of the economy.

The estimates of State Domestic Product can therefore be defined as a set of systematic statistical statements which reflect the total value of final output in monetary term produced within the geographical boundaries of the state during a particular year. The estimates also help to understand about the working of various sectors in shaping up the economy of the state and its inter-relationship between the different sectors of the economy. As such these estimates of State Domestic Product are considered to be the important parameters which could throw some light on the standard of living of the people as well as the level of income.

With a view to keeping pace with the fast growing economic scenario that are taking place within the Country / State, it has become desirable to rebase the estimation of the State Domestic Product Series periodically and also in order to capture those commodities / services that are either emerging or could not be considered or covered earlier. Therefore shifting of base year from one period to another needs a comprehensive study both in structural changes in the economy as well as of recent data bases. In this context, Government of India has appointed a technical Advisory Committee on National Account Statistics to review and make necessary recommendations to the Central / State Statistical Organisations in the manner of those guidelines framed by the United Nations, System of National Accounts (S.N.A 1993). Accordingly, the National Accounts Statistics, Central Statistical Organisation, Government of India has shifted the base year from 1980-81 to 1993-94 with the following improvements of data base and methods.

- (1) Working force is to be based on the Quinquennial Survey of Employment and Un-employment 43rd and 50th Rounds of National Sample Survey Organisation (N.S.S.O) in place of Population Censuses 1981/1991.
- (2) Adjustment of Financial Intermediation Services indirectly measured (FISIM) to the concern Industries / Sectors.
- (3) Inclusion of (i) additional item of Fruits and Vegetables (ii) Floriculture and (iii) Foreyard and Backyard cultivation to Agriculture Sector.
- (4) Inclusion of Gobar gas to the Electricity, Gas and Water supply sector.
- (5) Inclusion of legal services to the Real Estate, Ownerships of dwellings sector which are earlier in Other Services.
- (6) Inclusion of Quasi-Government (NIC 903) to the Public Administration.
- (7) Inclusion of International and Extra-territorial services to the other service and also to prepare separate estimates for Tailoring services (NIC 969) which was earlier clubbed with rest of services.

In the estimation of State Domestic Product, three approaches have been adopted and these are Production, Income and Expenditure. Each one of the above approaches is suitably applied to the sectors according to the availability of requisite information.

Production approach is used in the estimation of income from those sectors which direct data on production and prices are directly available for both outputs and inputs items, such as Agriculture and allied activities and Registered Manufacturing.

Income approach is followed for the estimation of income of those sectors where information are available only on the factor incomes like service sectors etc.

Expenditure approach is applied for those sectors in which the data required are not available either on production or factor incomes but at the final output only.

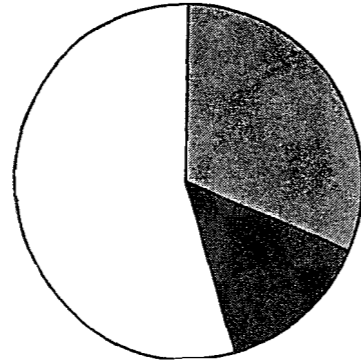

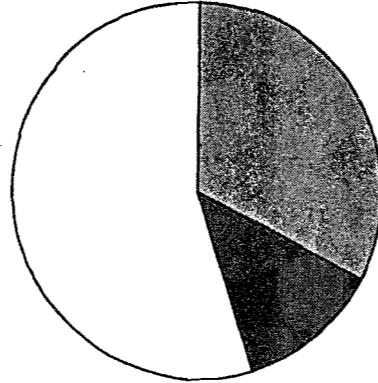

Sectoral Estimates of Gross Domestic Product at Current Prices

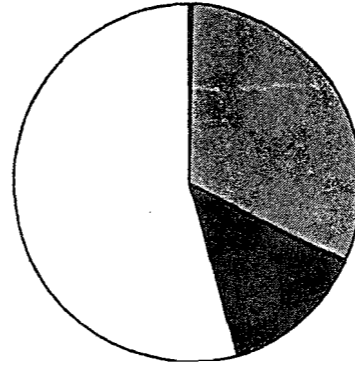

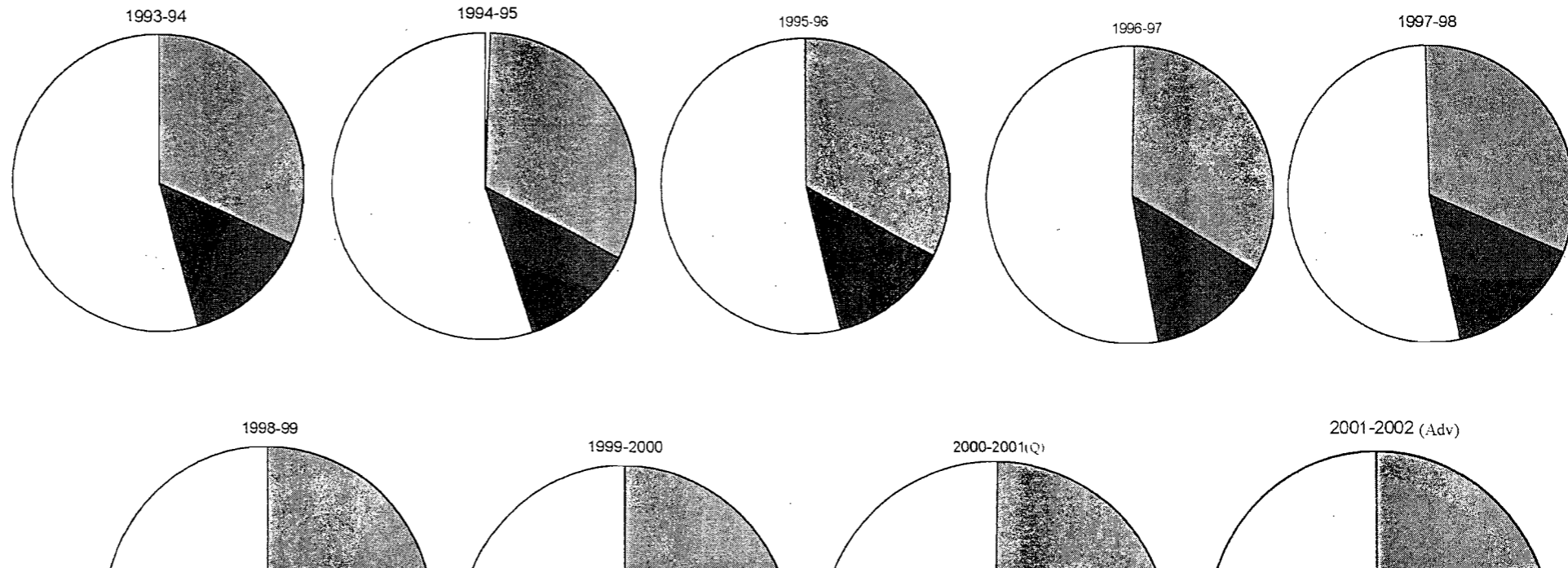

Per Capita Income Gross Domestic Product Current / Constant Price

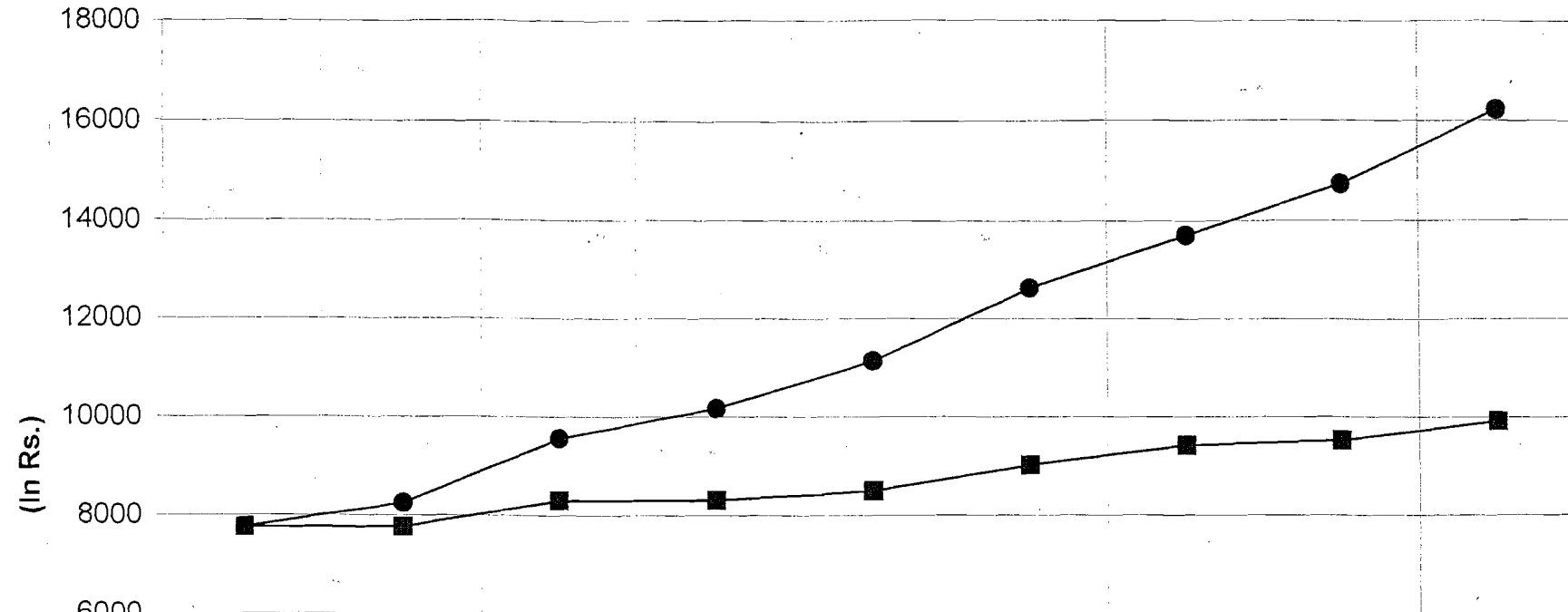

Sectoral Estimates of Net Domestic Product at Current Prices

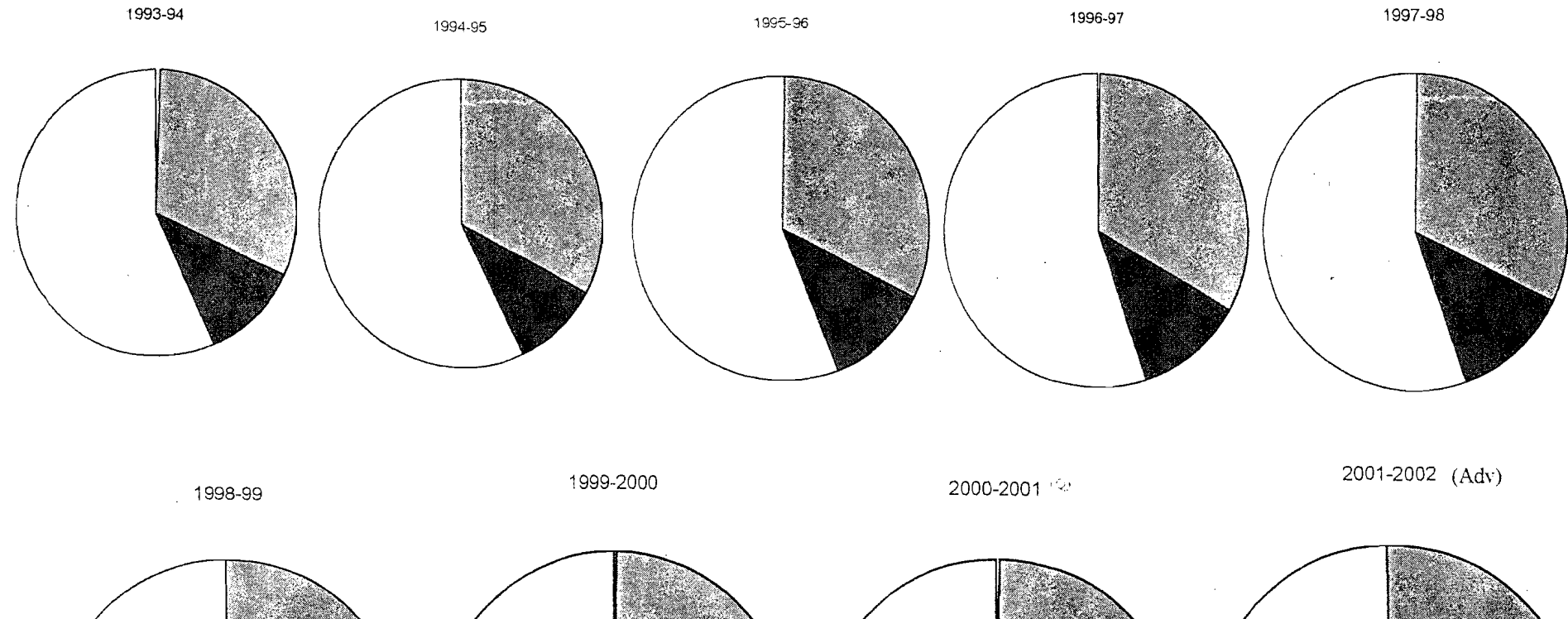

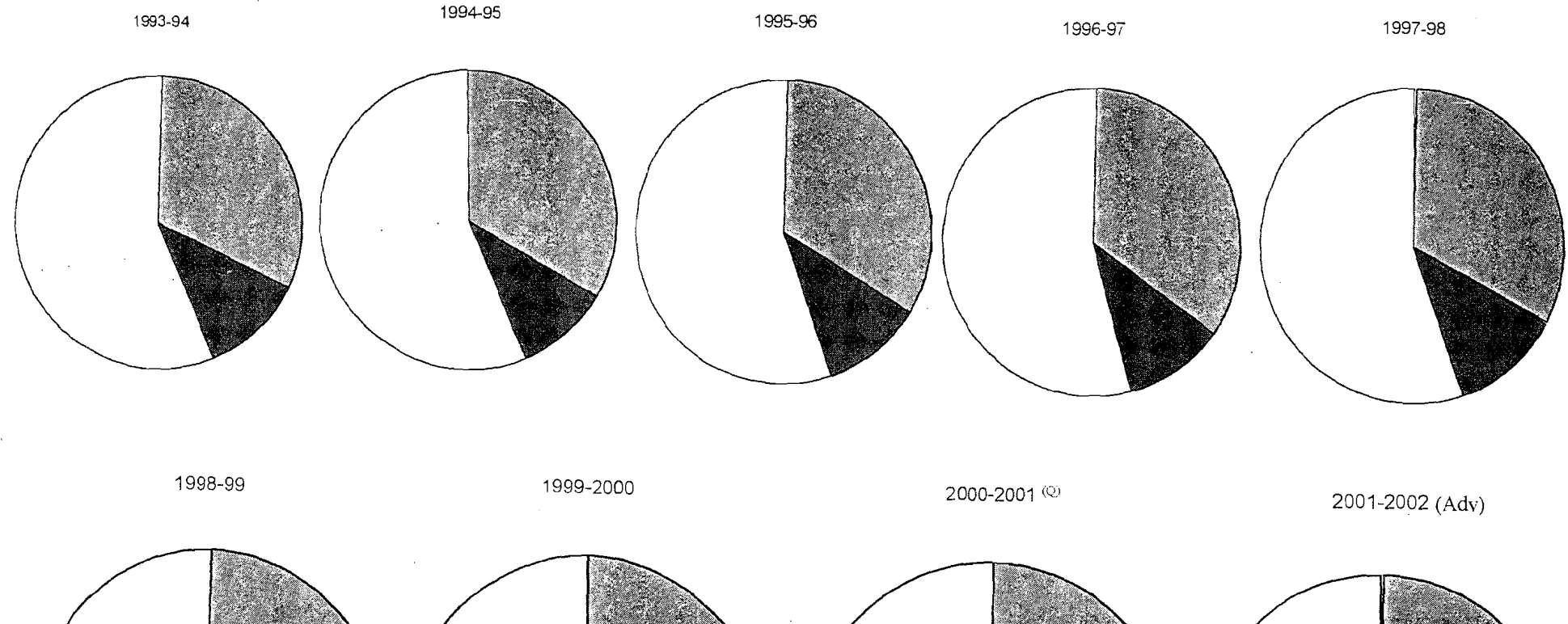

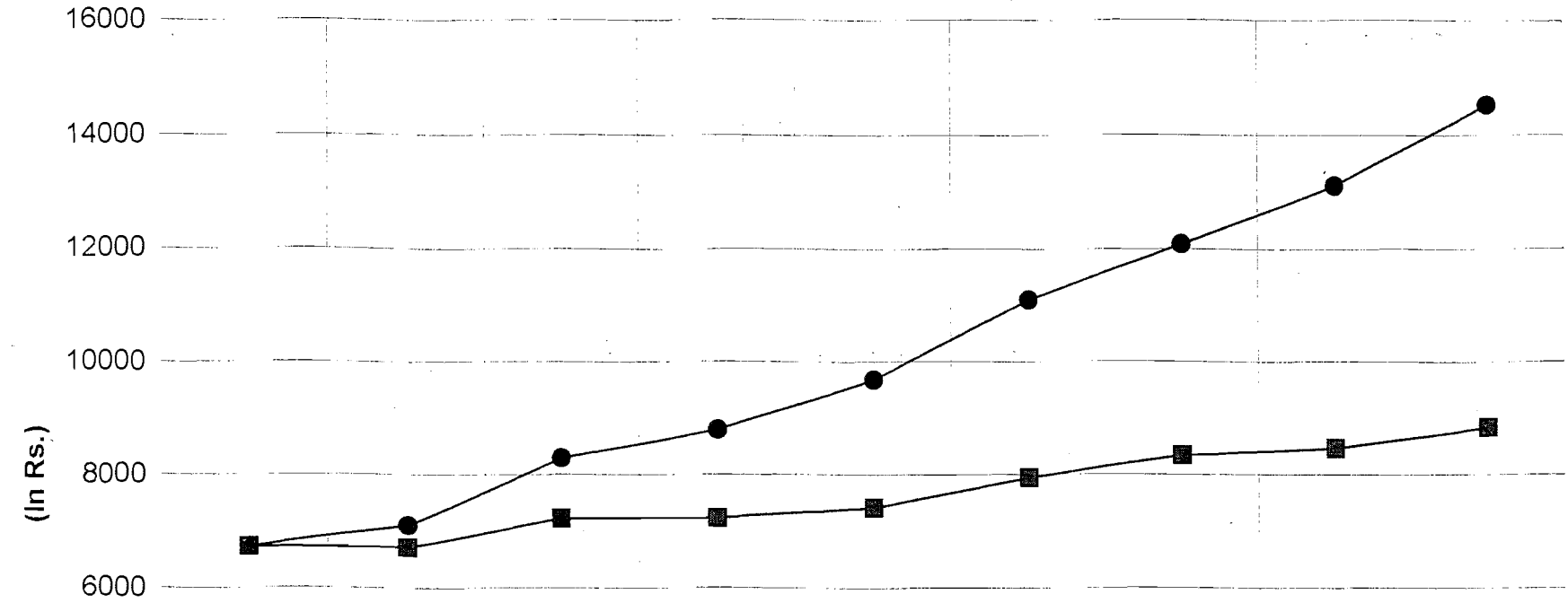

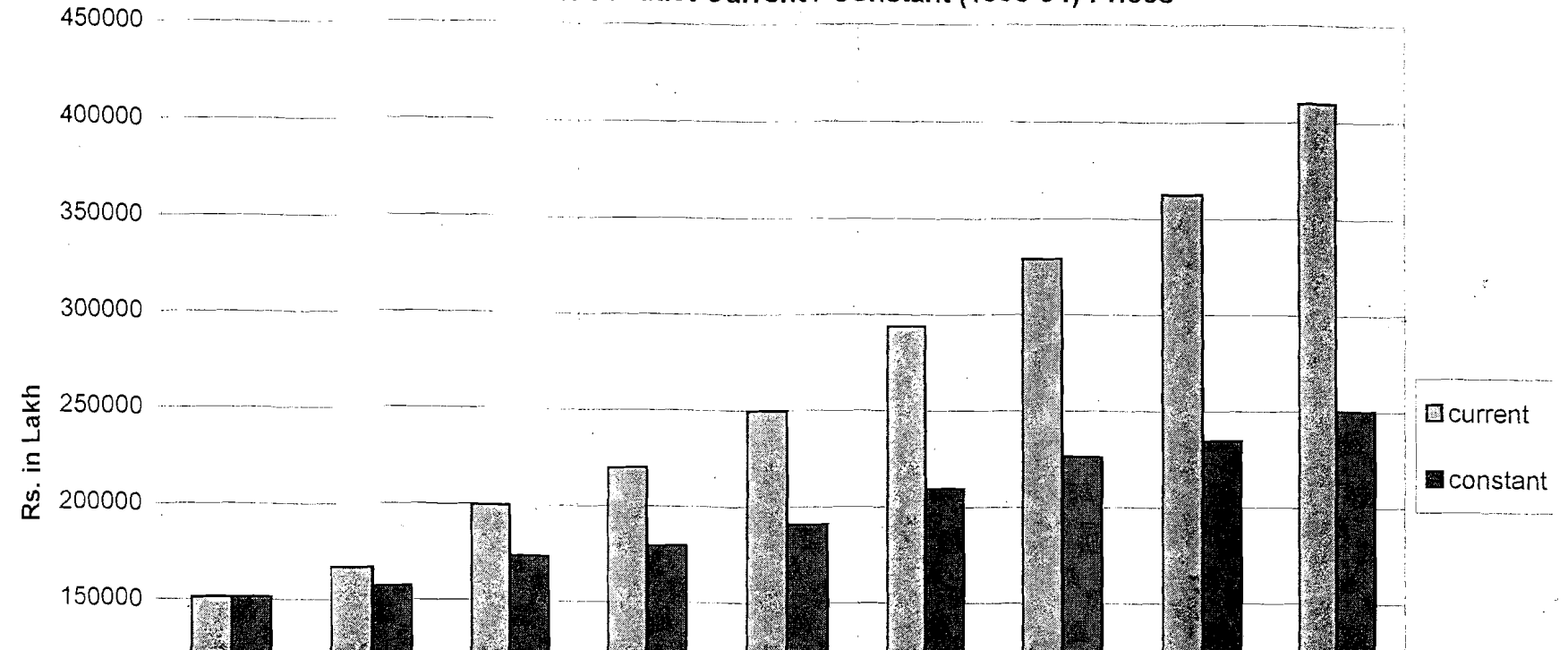
