1. Tender should quoted to be accompanied by Earnest Money at 10% of the bid money be submitted duly pledged in favour of the Director of Economics and Statistics. Earnest Money as far as practical should be in form of Deposit at call duly pledged in favour of the Director, Economics and Statistics, Meghalaya, Shillong. Earnest Money in any other recognized form like National Saving Certificate, Fixed Receipt are also acceptable provided they are duly pledged in favour of the Director of Economics and Statistics. The amount quoted should be above ₹15,000/- (Rupees Fifteen Thousand) only and the highest bidder will be awarded.
2. Rate quoted for the vehicle in Tender should be written clearly both in figure and in word any overwriting should be duly attested.
3. Tender should be addressed to the undersigned by designation and not by name Sealed envelope containing the Tender must be super scribed by words "Tender for purchase of Condemned Vehicle" and be sent by Registered post or deposited in Tender Box in the office of the Director of Economics and Statistics, Meghalaya, Shillong.
4. The following documents should be attached with Tender. Tender received without the required documents will be summarily rejected.
 - a) Attested copy of Photograph of the Tenderer.
 - b) Up – to – date trading Licence in terms of KHADC Regulation Act to whomever applicable.
5. The intending Tenderers may inspect the condemned vehicle as noted above at the location on any working days from 11:00 hrs to 16:00hrs.
6. The successful Tenderers shall be intimated and a letter of acceptance will be issued by the undersigned.
7. The accepted price in full will have to be deposited by the successful Tenderers and the vehicle removed at his/their own cost within the date fixed for the purpose by the Directorate.
8. The undersigned will not be held responsible for any loss or damage of the condemned vehicle, if any, if it is not removed within the specific date.
9. The Earnest Money of the successful Tenderer shall be forfeited to Government if he fails to deposit the accepted price and lift the vehicles within the date fixed for the purpose.
10. The Earnest Money of the unsuccessful Tenderer shall be released after the award of tender to the successful Tenderer.
